- Lack of appropriate human capital: Higher wages, lower productivity
- Peoples aspirations for higher wages without high skill levels
- Poor / Developing infrastructure

- •Make Sri Lanka the most attractive logistic hub in the Asia-Pacific region, taking maximum advantage of the country location.

# Opportunities for businesses with Megapolis

- •Centre for Service Excellence in areas of primary, secondary and tertiary education.
- •Using the knowledge economy and the logistic capability to produce hi-end value added technology products eg: sensors, computer chips, biotechnology products etc
- Taking into account the high percentage of professionals in the country the, KPO's could be another opportunity
- •International center for financial arbitration, trade conventions, knowledge dissemination & corporate governance

# Moving beyond Labour arbitrage

If we move into some agriculture labour dominated economy towards the service and knowledge base economy, we would benefit from the following areas:

- Reduce the labour dependence on agriculture (30% of the people, resultant aggregation of land leading to mechanization and higher output)
- If skill gaps are bridged, the people could be working in areas of greater output and return.
- The challenge of being competitive in the low tech labour market is unsustainable and we should move to the next dimension.

#### Challenges for Businesses in this transition

In order for successful implementation of the Megapolis, we have to overcome the following challenges:

- Promoting a policy driven and a private sector led growth eg: Policy consistency and PPP
- •Strong implementation network with adequate legal teeth which can cut through the red tape.
- •To prevent capital flight the local private sector has to be given opportunity to invest, so they have enough skin in the game
- •The transformation of the workforce through educational skill development is another major challenge. If we overcome this we can ride the wave of success.
